




























Q1 2024 Commentary and Investment Outlook

As the quarter came to a close, the Federal Reserve in their most recent FOMC meeting left interest rates unchanged and released new quarterly economic projections. The projections focused on the economy (GDP), the unemployment rate, and prices (Personal Consumption Expenditures). The first two projections indicate continued strength in the economy for the remainder of this year and 2025. The PCE projection indicates gradual movement to the Federal Reserve's 2% target, over the next few years.


If these projections reflect what actually transpires, then the Federal Reserve will likely not crash the economy, causing a "hard landing", but will come closer to a "soft landing". If the inflation target is not reached in 2024, and the economy thrives, then "no landing" will be achieved. The term "no landing", is a new term for what has historically been called a "goldilocks" scenario.


As noted in the GDP chart, the economy is expected to grow 2.1%¹ this year, which is above the historical long-run average and significantly higher from the 1.4%² growth which was projected in The December 2023 Summary of Economic Projections. The economy has performed very well in the face of restrictive monetary policy, most likely due to the residual effects of the pandemic stimulus deployed by the Federal Reserve (monetary), and the Government (fiscal) to individuals and businesses. This is a goldilocks situation.



The employment picture is very positive as the economy has been adding 250,000³ jobs per month on a trailing one-year average. Companies continued to hire in the face of higher rates. The unemployment rate is expected to hit 4% by the end of 2024⁴, mostly unchanged from the 4.1% projected in December. As a reminder, 4-5% unemployment is considered full employment. Again, this occurred with a restrictive monetary policy and reinforces the second leg of the goldilocks situation for the Fed.

The chart is the annual PCE, year-over-year percentage change, but as a reminder, the economic release occurs monthly which contains twelve data points. These monthly releases often do not move in one direction, but often have months that show prices increase at a greater percentage than expected and higher than the previous release. That is why economists look for directional trending, which considers monthly volatility of inflation data, but the focus is on a trend in a direction over time. The projection clearly indicates the disinflationary downward trend in the data from its peak in 2022.

The FOMC interpreted data showed that inflation at the start of 2024 remained "elevated". However, the view on inflation did not change the overall narrative. Chairman Powell spoke about prices in his press conference.⁵ Inflation is "moving down gradually on a sometimes bumpy road to 2%". His comments indicate that the Fed will monitor inflation, and if price pressures do not ease, the Fed will maintain higher interest rates as long as needed. This is a "no landing" scenario.

Officials affirmed their view for three rate cuts this year, even as they raised their economic outlook⁶.

What does this mean for interest rates and bonds? Goldilocks/"no landing" means that rates will remain higher for longer and the chances of a "soft landing" increase. We project that the Federal Reserve will start cutting the Overnight Target Rate in the latter half of 2024, but if rates are cut two or three times, rates will remain higher (restrictive) for years to come.

If this is the case, the yield curve should steepen over time, but it may not occur entirely by way of shortterm rates, it may occur with longer-term rates rising, faced with the reality that the Federal Reserve can remain restrictive longer.

A "no landing" scenario will continue to favor short-to-intermediate maturity strategies over longer maturity strategies. "No landing", considers an overall stable economy, which allows companies to thrive. While there could be issues of concern over the next year that may affect the economy, a "no landing" scenario means that inflation takes a little longer to achieve the target rate as the economy remains resilient and unemployment remains low.

³ US Employees on Nonfarm Payrolls, Bureau of Labor Statistics, trailing 12-month average, March 2024




Economic Commentary – March 2024

Belying the satirical aphorism, "Beware of the Ides of March", the public fixed income and equity markets experienced a revival of positive correlations as both ended the month in positive territory. On the backdrop of staunch consumer spending, a relentlessly resilient labor market, an overall softening in supply-side constraints, S&P 500 companies' solid fundamentals, and a U.S. economy that continues to expand at a pace that is above historical trend growth, market participants and investors alike have fostered an appetite for risk assets while concurrently dialing back expectations for rate cuts in 2024.

On March 20, at the conclusion of the Fed's second policy meeting of the calendar year, the FOMC once again unanimously voted to maintain the federal funds target rate range at 5.25% - 5.50%. This was the fifth consecutive pause (inaction) by the FOMC where policymakers ultimately decided to hold the aforementioned rate range at a 22-year high that has been sustained since July 2023. Cited directly in the FOMC Statement and Chair Powell's post-meeting presser, "The Committee does not expect it will be appropriate to reduce the target range until it has gained greater confidence that inflation is moving sustainably toward 2%." As was mentioned in last month's commentary, we're currently in the terminal phase of the Fed's rate-hiking cycle which commenced in March 2022. While acknowledging that overall progress has been made on subduing inflation, it is this final stage which always proves to be the most onerous, and the central bank has endeavored to assuredly rule out any prospect of an undesired reacceleration in inflationary pressures before it enacts a rate reduction.

While no policy action at the March meeting was widely expected and priced into market dynamics, it was the release of the Fed's updated Summary of Economic Projections that was the most compelling and coveted source of information amongst market participants as it provided deeper insights into the Committees' assumptions and forecasted trajectory for the remainder of 2024. Revised from December 2023's projections, the change in real GDP was boosted to 2.1% from 1.4%, core PCE inflation was increased to 2.6% from 2.4%, the unemployment rate was ticked down 0.1% to 4.0%, and headline PCE inflation was unchanged at 2.4%. Concerning interest rates, the longer-run neutral rate was edged up 0.1% to 2.6%, and the median fed funds rate at the end of 2024 was unchanged at 4.6%. On the surface, an unrevised fed funds rate may seem trivial. However, dissecting the newly released dot plot reveals an underlying dichotomy that exists amongst Fed officials. 10 of 19 members still anticipate making three rate cuts or more in 2024, while 9 of 19 members expect to make two cuts or fewer. Therefore, one shift in opinion either above or below the median rate would have the effect of altering the forecasted target rate of 4.6%, and consequently formulate the market's perception of whether the central bank has a dovish or hawkish outlook.

As Chairman Powell and other Fed policymakers regurgitate recurrent data dependence rhetoric and emphasize the importance of preserving a patient approach, the interest rate futures market is now in harmony with the FOMC's projections of two/three rate cuts in 2024. However, as macroeconomic barometers continue to indicate a robust economy, we expect this period of protracted pauses to extend into the summer months.

March 2024 Macroeconomic Highlights

Inflation, Expectations, and Consumer Sentiment¹:

Labor Market²: The U.S. economy added 275,000 nonfarm payrolls in February, exceeding the 200,000 expected by economists surveyed by Bloomberg. Notable job gains occurred in health care (+67,000), government (+52,000), food services and drinking places (+42,000), social assistance (+24,000), and construction (+23,000).

- U-3 official unemployment rate: 3.9% vs. 3.7% expectation: +0.2% from January 2024.
- U-6 unemployment rate (marginalized, part-time workers for economic reasons): 7.3% (+0.1%).
- Labor force participation rate: 62.5% (unchanged); Employment-to-population ratio: 60.1% (-0.1%).
- Average hourly earnings for private nonfarm payrolls rose 5 cents to \$34.57 (+0.1% month-over-month, +4.3% year-over-year).
- Employment revisions: January 2024 sliced -124,000 to 229,000; December 2023 cut -43,000 to 290,000.

Gross Domestic Product (GDP)³: According to the *third and final* estimate, real GDP increased at annual rate of +3.4% in the fourth quarter of 2023 vs. +4.9% in the third quarter of 2023. Real GDP increased +2.5% in 2023.

- Fourth Quarter 2023: GDP Price Index: +1.6%; PCE Price Index: +1.8%; Core PCE Price Index +2.0%.
- Real disposable personal income: +2.0% vs. +0.3% in the third quarter of 2023.
- Personal savings rate as a percentage of disposable income: 4.0% vs. 4.2% in the third quarter of 2023.
- Average of Real GDP and Real GDI: +4.1% vs. +3.4% in the third quarter of 2023.

Housing Market⁴: Existing-home sales surged +9.5% (month-over-month) from January to a seasonally-adjusted annual rate of 4.38 million in February. Month-over-month sales in the West, South, and Midwest jumped +16.4%, +9.8%, and +8.4%, respectively, while sales in the Northeast were unchanged.

- Year-over-year sales waned -3.3%, down from 4.53 million in February 2023.
- Total housing inventory registered 1.07 million units, +5.9% from January, and +10.3% from one year ago (0.97 million units). Unsold inventory sits at a 2.9-month supply at the current sales pace.
- The median existing-home price for all housing types was \$384,500, +5.7% from February 2023 (\$363,600), as prices rose in all four major U.S. regions.
- Average commitment rate for a 30-year, conventional, fixed-rate mortgage: 6.79%.
- New Home Sales: 662,000 (-0.3% month-over-month).
