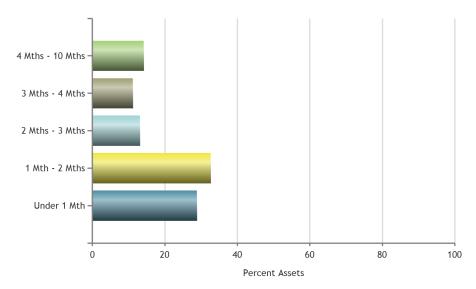

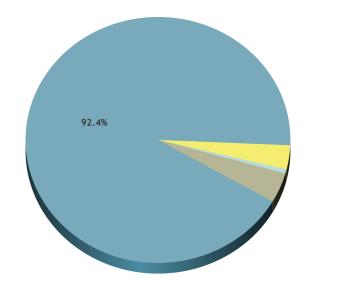

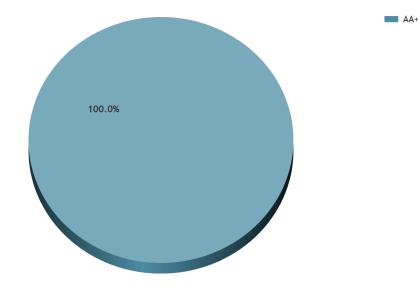

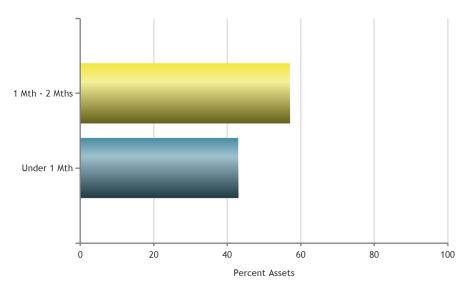

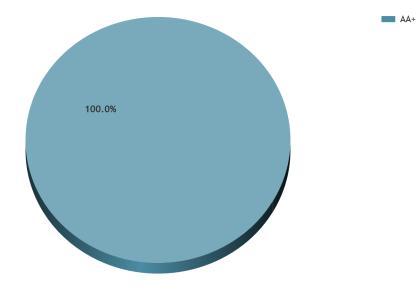

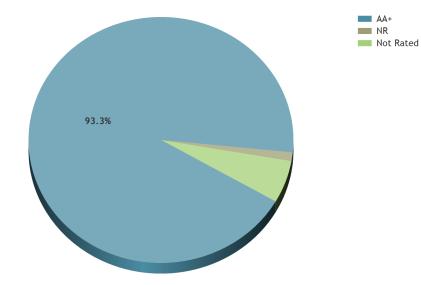

## **Economic Commentary and Investment Outlook**





### Q3 2024 Commentary and Investment Outlook

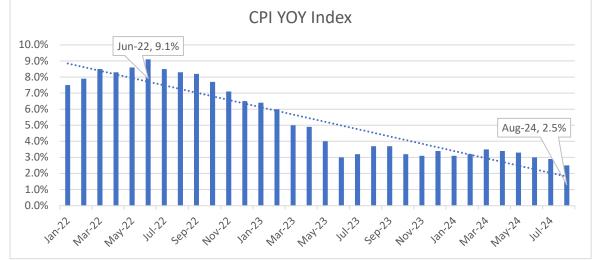
The third quarter of 2024 has been marked by a significant change in interest rate policy by the Federal Reserve and the beginning of a new cycle of interest rate movements. This will likely lead to the federal funds target rate being lowered over the next year. These cuts might not occur at every Federal Open Market Committee (FOMC) meeting, however the signal has been made by Chairman Powell that the Fed is now entering a phase of less restrictive monetary policy going forward.

In the FOMC September meeting, in a rate decision that came as a slight surprise, the committee voted to reduce its benchmark overnight borrowing rate by 50 basis points<sup>1</sup>. It was the first time the committee had cut rates by that much since the COVID-19 pandemic, and before that, the Great Financial Crisis of 2008. The current fed funds rate is targeted in the range of 4.75% - 5.00%<sup>2</sup>.

The rate cut intimated that the Fed is on its way to lowering the policy rate to a more "neutral" position. In the latest economic projections, the Federal Reserve indicated that the "neutral" rate is around 2.9%.

As Chairman Powell noted, the shift in policy was needed because economic data stabilized, including inflation data, employment figures, and GDP growth. Powell noted that, "We can go quicker or slower, or pause on rate cuts if it is appropriate." This signals a more cautious approach to future rate cuts.

Several key economic indicators suggested that a more accommodative policy would be appropriate.



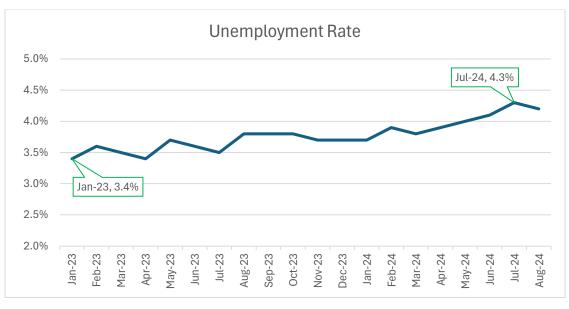
1. Inflation trending towards the FOMC's target of 2%, as reflected in headline CPI chart below.

2. Unemployment rates have remained low at 4.1% in September, but have moved higher from the low of 3.4% in January 2023 as indicated in the chart below. Year-over-year wage growth has decelerated, which may signal a reduction of future inflationary pressures.<sup>3</sup>

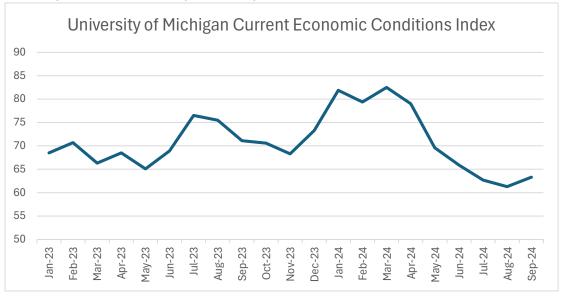

3. Consumer confidence has been trending lower, raising concerns about future spending, which could indicate a slowing economy going forward. The University of Michigan Current Economic Conditions Index indicated a drop in overall consumer confidence for 2024. Current domestic uncertainty about the presidential election and recent natural disasters have created some hesitancy with consumers to spend money.

The performance expectations for fixed income securities during this cycle should be very positive. Overall investor sentiment towards fixed income is likely to remain favorable for the next year as well. Anticipated rate cuts are expected to lead to price appreciation for fixed income securities. When

interest rates decline, the prices of existing bonds typically become more attractive. Investors seeking stable returns may flock to bonds, pushing prices higher, and increasing returns for bondholders. The extraordinary bull market in equities may cause a strategic reallocation to fixed income markets as participants may opt to lock in gains and reallocate to a less volatile asset class. Ongoing geopolitical tensions in Ukraine/Russia and the Middle East may lead to pressures on global supply chains and energy prices, which may also trigger a flight-to-quality environment.

As we enter the fourth quarter, our longer maturity strategies will be duration neutral to respective benchmarks as we increased duration throughout 2024. We will also maximize corporate credit exposure in portfolios where applicable, as we favor the asset class in this environment. Moreover, government agency holdings will likely decrease in our portfolios as spreads are often in line with those of Treasuries.

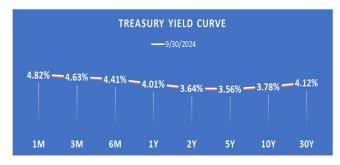
## **Economic Commentary – September 2024**

On Wall Street, it's seldom that a scheduled central bank policy meeting would command the signifcance to overshadow the continued upward surge and positive performance of both the equity and bond markets. September 2024 happened to be that outlier. After holding its overnight benchmark rate range steady at a 23-year high since July 2023 at 5.25% - 5.50%, on September 18, at the conclusion of the Fed's sixth policy meeting of the calendar year, the FOMC enacted an outsized rate cut of 50 basis points, reducing the federal funds target rate range to 4.75% - 5.00%. While a myriad of market participants and the interest rates futures market expected (and yearned) for the aggressive half-percentage-point reduction, there was a large cohort of economists that held the notion that only a 25 basis point abatement was necessary. In fact, Fed Governor Michelle Bowman was the lone dissenting vote, favoring a 25 basis point cut, which marked the first dissenting vote from a Fed Governor since 2005.

In addition to the highly anticipated rate-cut decision, the Fed also released its quarterly updated Summary of Economic Projections (SEP), which provided deeper insights into the Committee's assumptions and forecasted trajectory for the remainder of 2024. Revised from June's projections, headline PCE inflation and core PCE inflation were scaled down -0.3% and -0.2%, to 2.3% and 2.6%, respectively. The change in real GDP was slightly lowered to 2.0% from 2.1%, while the unemployment rate was lifted to 4.4% from 4.0%. Regarding interest rates, the longer-run neutral rate was ticked up +0.1% to 2.9%, and most compellingly, the year-end median federal funds rate was reduced to 4.4% from 5.1%, indicating that in aggregate, policymakers expect to further slash rates a combined 50 basis points in 2024, augmenting the 50 basis point curtailment that was just undertaken at the September meeting.

While the SEP forecasted 50 more basis points in cumulative rate cuts before the conclusion of the year, parsing the updated dot plot highlighted stark divergences amongst policymakers. Of the 19 Fed officials, two anticipated no further reductions, seven expected to make one additional 25 basis point reduction, nine penciled in a total of 50 basis points more in rate cuts, and one official projected an additional 75 basis points in total cuts.

In his post-meeting press conference, Chairman Powell described the rate-cut decision as a recalibration of monetary policy, moving from a restrictive stance that was geared toward quelling inflation, to a position that is more suitable to hinder any further deterioration in the labor market. Asserting that he and other Fed officials view the economy as strong and that a recession is not the central bank's base case, he did not shy away from underscoring that signs of weakening in the labor market were the main determinants behind the initial 50 basis point reduction. However, he made it a point to emphasize that the FOMC was not on a preset course regarding the size, scope, and timing of future rate-cut decisions. It's clear the Fed has shifted its attention in its dual mandate more towards preserving the strength of the employment landscape. Traditionally, absent looming recession risks, it's unusual for the FOMC to commence a rate-cutting cycle with a half-percentage-point reduction. The Committee usually opts to begin with a 25 basis point cut, employing a disposition of gradualism in their alteration of monetary policy.



U.S. Treasury yield curve extended its bull steepening trend as yields in all tenors subsided. Money-market yields underwent the largest descents on the backdrop of the Fed decision, while the longer end of the yield curve continued to normalize, disinverting the key 2y/10y pair.

## September 2024 Macroeconomic Highlights

### Inflation, Expectations, and Consumer Sentiment<sup>1</sup>:

**Labor Market<sup>2</sup>:** The U.S. economy added 142,000 nonfarm payrolls in August, slightly short of the 165,000 expected by economists surveyed by Bloomberg. Notable job gains occurred in construction (+34,000), health care (+31,000), and social assistance (+13,000).

- U-3 official unemployment rate: 4.2% vs. 4.2% expectation: -0.1% from July 2024.
- U-6 unemployment rate (marginalized, part-time workers for economic reasons): 7.9% (+0.1%).
- Labor force participation rate: 62.7% (unchanged); Employment-to-population ratio: 60.0% (unchanged).
- Average hourly earnings for private nonfarm payrolls rose 14 cents to \$35.21 (+0.4% month-over-month, +3.8% year-over-year).
- Employment revisions: July 2024 pared -25,000 to 89,000; June 2024 clipped -61,000 to 118,000.

<u>**Gross Domestic Product (GDP)**<sup>3</sup></u>: According to the *third and final* estimate, real GDP increased at an annual rate of +3.0% in the second quarter of 2024 vs. +1.6% in the first quarter of 2024.

- Second Quarter 2024: GDP Price Index: +2.5%; PCE Price Index: +2.5%; Core PCE Price Index +2.8%.
- Real disposable personal income: +2.4% vs. +5.6% in the first quarter of 2024.

- Year-over-year sales ebbed -4.2%, down from 4.03 million in August 2023.
- Total housing inventory registered 1.35 million units, +0.7% from July, and +22.7% from one year ago (1.10 million units). Unsold inventory sits at a 4.2-month supply at the current sales pace.
- The median existing-home price for all housing types was \$416,700, +3.1% from August 2023 (\$404,200), as prices rose in all four major U.S. regions.
- Average commitment rate for a 30-year, conventional, fixed-rate mortgage: 6.08%.
- New Home Sales: 716,000 (-4.7% month-over-month).
